Voting shall be taken as the last item of business at the Annual General Meeting and can only be taken if a minimum of ten (10) Charter Polo Playing Members participate in the voting. A nominee is elected as a Charter Polo Playing Member if a minimum of seven (7) or a two thirds majority of all votes cast are in his favour, whichever is the greater. A nominee so elected shall with immediate effect from the close of the Annual General Meeting be a Charter Polo Playing Member.
