The instrument appointing the proxy shall be in the following form, or a form close thereto;-</li> </ul></li></ul>	Rule 39 is proposed to be changed to provide for proxies to be used only where provided for in the Constitution i.e. at Rule 9, Rule 36, Rule 40 and Rule 52.  Rule 39 provides for the entitlement only to a proxy for a certain membership category (Charter Polo Playing Membership).  In the current Constitution the exercising of the proxy is provided for only at Rule 9, Rule 36, Rule 40 and Rule 52.  Currently Rule 39, the entitlement to proxies, is being used for any and all voting, which is not what is intended.  The only provision for proxies is at Rule 9, Rule 36, Rule 40 and Rule 52.
